What are the tax benefits of being a member?



If your tax residence is in Spain, according to Law 49/2002, of 23 December, on the tax regime of non-profit organisations and tax incentives for patronage, for a contribution of €60 per year, you will be deducted €48 from your income tax return. The Pau Costa Foundation will send you the donation certificate during the first quarter of the year. If your tax residence is not in Spain, Law 49/2002 does not apply for you and the Pau Costa Foundation won't send you the donation certificate unless you ask for it by sending an email to members@paucostafoundation.org.
